Item One - Pre-Alteration Asbestos Testing

<u>Item Two – Carpet Tile</u>

Revisions to the scope are shown in red text below:

Contractor will be responsible for the following items:

- Furnish and install Ramboard or equal to protect existing carpeting along all paths of travel and within 3'-0" of wall surfaces. Protect existing finishes adjacent to the area of work that are along your path of travel.
- Remove existing broadloom carpet in secure corridor.
- Furnish and install carpet tile and adhesive in restricted corridor. Carpet will be Bentley
 Burnish 402923 Mono Lake Redacted 801224 Treatise with NexStep Cushion backing, or
 approved equal. Adhesive will be Heathbond 2399. Carpeting will be glued directly to concrete
 subfloor. Orientation of carpet tile will be determined during mock-up with contractor prior to
 installation.
- Furnish at least 5% of carpet material as whole tiles (boxed) to USDC for attic stock.

<u>Item Five Six - Miscellaneous Accessories</u>

Revisions to the scope are shown in red text below:

Contractor will be responsible for the following items:

• Furnish and install two stainless steel corner guards at entrance to restricted corridor. Guards shall be Construction Specialties CO-8 SS Corner Guards with 3-1/2" legs, or approved equal. Guards shall be approx. 48" in height and shall have pre-drilled countersunk holes. Guards shall be composed of 16 ga. Type 304 stainless steel alloy. Final height of guards will be determined in shop drawings to accommodate USMS wall-mounted box near corner.
