Item One - Pre-Alteration Asbestos Testing

No additional information requested.

Item Two – Refinish Hardwood Flooring

Revisions to the scope are shown in red text below:

Contractor will be responsible for the following items:

- Relocate existing furniture, fixtures, and wall-hung accessories as necessary to complete this work. Protect all furniture, fixtures, and wall-hung accessories from dust and debris.
- Remove and dispose of all beige area rugs and associated pads, if present, in 301 Reception, 302, Judicial Ass't, and 306 Visiting Judge.
- Furnish and install Ramboard or equal to protect existing carpeting along all paths of travel and within 3'-0" of wall surfaces. Protect existing finishes adjacent to the area of work that are along your path of travel.
- Sand and refinish prepare all stained wood flooring throughout chambers according to NOFMA accepted methods. Refinish wood floors. Stain color for flooring shall be darkened to match stain color of wood base and chair rail more closely.
- Protect stained flooring with Advantage Coating Technogies' Top Knot 2-part waterborne wood finish, or approved equal. Sheen to be selected by USDC prior to pre-construction conference. Apply finish coat per manufacturer's instructions detailed in attached specification.

Item Three - Wall and Ceiling Paint

No additional information requested.

Item Four - Trim Stain and Paint

Revisions to the scope are shown in red text below:

Contractor will be responsible for the following items:

- All painted door frames shall receive one coat of primer and one coat of Sherwin-Williams ProClassic Alkyd Enamel. Color and sheen to match existing as closely as possible. Final sheen and color selection to be confirmed by USDC during submittal process; however, the paint color will be as close as possible to current paint color. Recaulk around all door trim. Caulking to match paint.
- Refresh all stained woodwork, including doors and trim, throughout with Old Masters Gel Stain Mohawk Scratch-Off for Dark Finishes M840-200x, or approved equal. Product sheen to be selected by USDC prior to pre-construction conference. Stain may need to be custom mixed from manufacturer's standard selections to match existing wood stain / finish more closely.
- Protect final product with Old Master polyurethane, or approved equal. Contractor to pour small amount of Scratch-Off onto a soft cloth. Wipe over wood surface and allow to remain on

the area for a few seconds. Wipe dry with another soft cloth.

• Provide at least one quart of each paint color to USDC for attic stock.

Item Four Five - Misc. Accessories

Item number was corrected. Revisions to the scope are shown in red text below:

Contractor will be responsible for the following items:

- In 306 Visiting Judge and 309 Conference, remove existing metal faceplates, and replace with plastic faceplates to match color of existing faceplates.
- In 308 WC / Shower, removed and dispose of wall-hung metal medicine cabinet. Patch wall as necessary to accept new paint.
- In 308 WC / Shower, remove and dispose of burgundy plastic accessories, including cup holder, tray, toilet paper holder, towel rod, and two hooks. Patch wall as necessary to accept new paint.
- In 309 Conference, furnish and install two covers for recessed sprinkler heads in ceiling.
- Furnish and install new Bobrick B-540 Surface-Mounted Toilet Tissue Dispenser and Utility Shelf, B-295 Stainless Steel Shelf behind toilet, B-677 Towel Pin at shower, and B-2116 at door. All fixtures shall be satin stainless steel unless otherwise noted.

Item Five Six – Tenant Alteration

Item number was corrected. Revisions to the scope are shown in red text below:

Contractor will be responsible for the following items:

- Remove existing light switches and replace with illuminated switches.
- Remove existing flush-mounted and recessed light ceiling fixtures in 308 WC/Shower and replace with four Topaz 4" RDL LED can lights, or approved equal. Finish, lumen output, and color temperature to be selected by USDC; however; lumen levels must be equal to or higher than current fixtures.

Scope for tenant alterations includes one or more switches in these rooms/spaces:

301 Reception	• 304 Law Clerk	• 307 Robing
• 302 Judicial Ass't	• 305 Service	• 308 WC / Shower
• 303 Law Clerk	• 306 Visiting Judge	• 309 Conference

Alternative One – Ceiling Patches and Prep in 308 WC / Shower

This alternative will only be awarded if Item 6 – Tenant Alterations is awarded.

Contractor will be responsible for the following items:

- Patch existing openings for removed light fixtures in 308 WC / Shower. Diameter of new fixtures is smaller than the existing light fixtures.
- Finish patches and prime to receive new finish coats as detailed in Item Three.

Recoating Floors

Be certain floor is free of wax or oily residue. Clean floor thoroughly with Advantage Hardwood Floor Cleaner. Abrade floor with maroon abrasive pad (approx: 220 grit). Vacuum thoroughly. Tack with slightly damp mop or cloth. Apply finish. Note; Advantage Coatings finishes will adhere to most stains and finishes after proper preparation and dry times. Always prepare a sample or test area to determine compatibility.

Sanding and Finishing New Floors

Sand and prepare floors according to NOFMA accepted methods. For stained floors make a final cut with 80 grit paper and 80-100 grit screen. For unstained floors make a final cut 80–100 grit paper and screen 120–150 grit to minimize grain raise. Vacuum thoroughly and tack with slightly dampened mop or cloth. Abrasion between sealer and finish coats is not necessary for adhesion unless it has been more than 48 hours since the previous coat has been applied. For best results always vacuum and tack after abrading.

Finishing

Shake well. Remove cap and allow sealer or finish to equilibrate for 5 minutes. Pour a 4-6" wide line of finish with the grain along the starting wall. Use a clean pre-dampened applicator and pull the applicator forward with the grain of wood holding the applicator at a "snowplow" angle moving the puddle toward the opposite wall. Replenish the puddle, maintaining a wet edge. After each turn, pad out applicator and feather out all turns. To prevent lapping and dry marks use recommended coverage rates. (400–600 sq.ft./gallon). Allow finish to dry 2-3 hours. High humidity and/or low temperatures will extend drying times. Allow final coat to dry at least 48 hours before use.

Curing

The curing process takes approximately 7 days. Do not replace rugs or mats until the floor has fully cured. The floor may be walked on after 24 hours, but the floor is susceptible to scuffing or marring prior to completion of the curing time. **Do not clean with** water or detergent during the first week.

Clean Up

Tools should be cleaned with water.

Maintenance

Put walk off mats at all entrances to keep out dirt and grit. Sweep or vacuum as needed. Damp mop with Advantage Hardwood Floor Cleaner. The floor may be buffed with white polishing pad to restore luster.

Shelf Life

Minimum of one year in an unopened container.

Caution

Contains small amounts of P-series glycol ethers and NMP. Do not breathe vapors or spray mist. Use with adequate ventilation. Avoid contact with eyes, skin and clothing. Wash thoroughly after handling. Keep containers closed when not in use. Do not store above 100°F.
